



Queensland

Enjoy outdoor sports and alfresco dining, spend time with new friends, go shopping, see wildlife in its native habitat, follow the trails of early Outback pioneers, or step back in time to view Aboriginal rock art.

The landscape features lush northern rainforests (including the world's oldest, the Daintree), red deserts in the west, and golden surf beaches in the south-east.

Home to the Great Barrier Reef, the planet's largest coral reef and one of the seven wonders of the natural world, Queensland's marine territory is significant for its cultural, natural, tourism and scientific value.

In the south-east, Brisbane is a gateway to some of the world's largest sand islands and a range of mountain retreats.

West of the Great Dividing Range (Australia's longest mountain range) are mine sites, wineries, cattle and sheep stations, and farms producing items such as bananas, pineapples, peanuts, fruit and vegetables, grains, cotton, and sugar cane that are chief contributors to the economy.





STUDY OVERVIEW

Programs and courses

At UQ, a degree is called a "program" and a subject is called a "course".

Programs are either "coursework", where you complete a specific number of courses to graduate, or "research", where you complete a research project to graduate.

Coursework

Undergraduate and postgraduate coursework programs involve mostly coursework, including lectures, laboratory work, tutorials, assignments and examinations.

Undergraduate coursework programs include bachelor degrees (including honours), associate degrees, dual programs, and concurrent diplomas.

Postgraduate coursework programs include graduate certificates, graduate diplomas, coursework masters, and professional doctorates.

Most coursework masters programs consist of a series of specialist courses in a structured class or seminar format in accordance with the Australian Qualifications Framework (AQF) requirements for a Masters Degree (Coursework). A research component is also required, however, the research component is shorter than that for a research masters program.

Research

At postgraduate level, research options are also available. Research higher degrees require that at least two-thirds of the program is supervised independent research (a thesis), although some limited coursework may be required. UQ offers two RHD programs, the Doctor of Philosophy (PhD) and the Master of Philosophy (MPhil).

Course choice

Course selection varies from faculty to faculty and from program to program. Some programs have compulsory (core) courses only, whereas others may allow a restricted choice within particular categories. Still others may offer an extended range of courses (electives), or you may have to undertake research projects. Please check your program's requirements very carefully.

Study load

A full-time study load is eight units (#8) per semester. Most courses are worth two units (#2), which means that you complete four courses per semester. However, some courses have higher workloads and may be worth four (#4) or eight (#8) units (generally research projects or theses). At the coursework doctorate level you may even enrol in a two-semester 16 unit (#16) course towards the end of your program.

To be eligible for an Australian Student Visa, international students must complete their studies within the visa duration. To ensure that you complete your program within visa duration, we strongly recommend that you undertake a load of #8 units each semester.

Course credit

You are not expected to repeat learning that you have successfully completed at a similar level and standard elsewhere, where that work is substantially the same as required for your UQ program. This means that you may receive credit for previous formal studies and recognised prior (informal) learning for both admission requirements and courses within a program.

Credit transfer

Credit transfer allows for a number of units, up to a specified limit, to be granted towards a UQ award on the basis of either previous formal or informal learning. If you have completed studies at another institution and are considering applying for credit, check the website for a list of courses that UQ has previously assessed for credit and established as precedents, as these will help you determine your own eligibility.

Exemption

While the total number of units required to satisfy program requirements will not be reduced, if you have some prior formal or informal learning you may not have to complete certain specified courses that would otherwise be core requirements in the program list.

Commencement

Semester 1 in Australia generally begins in late February, and Semester 2 in late July, but some programs may start earlier.

As a new international student, you should arrive at least one week before Orientation to get over jet lag, attend a *Getting Started* session, and settle in to housing. You will then get the most benefit from the many Orientation information and social activities available.

If you wish to attend the *Jump Start* Academic Preparation Program (JSAPP) you should arrive two weeks before Orientation. See page 1 for important dates

UNDERGRADUATE PATHWAYS

If you do not meet the admission requirements for your UQ program, consider the following pathways to undergraduate study at UQ.

The Foundation Year

The University of Queensland recognises the 30954QLD Certificate IV in University Preparation (CRICOS Course Number 075730A) offered by International Education Services (IES) as the exclusive Foundation Year for international students for entry into the first year of all undergraduate programs.

The Foundation Year provides a bridge between your secondary (high school) studies and undergraduate study at The University of Queensland. If you achieve specified standards you will receive a *30954QLD Certificate IV in University Preparation* and are guaranteed an offer into UQ's corresponding undergraduate programs*.

The Foundation Year program has two compulsory and three elective subjects, which will improve your communication skills and technical vocabulary. Foundation Year also provides intensive English language instruction designed specifically for international students.

The environment in Foundation Year is truly international, with enrolments from more than 40 countries. You will receive a high level of individual attention and will find it easy to make friends.

Foundation Year provides ongoing support services throughout your foundation and undergraduate studies, including:

- airport reception
- Orientation program
- accommodation placement service
- student counselling and career advice
- a self-access centre and access to the University Library
- access to computers and high-speed Internet connection plus free email accounts
- visits to UQ faculties to discuss program structures and related issues
- remedial tutoring for students experiencing difficulties with their studies

Associate Degree in Business

By choosing to study this 16-month (four trimesters) UQ-accredited Associate Degree in Business (AssocDBus), you will gain a strong stand-alone qualification.

If you complete the AssocDBus with a cumulative grade point average of 4 (on

a 7-point scale), you may also be eligible to apply for UQ's Bachelor of Business Management (BBusMan) and receive 24 units of credit (three semesters full-time) towards the BBusMan.

UNDERGRADUATE STUDY

Undergraduate programs are the first level of tertiary study and UQ offers a diverse range.

Undergraduate program structure

Bachelor degree

Bachelor degrees usually require between three and five years of full-time study, and provide knowledge and skills for work in a specialist area.

Within a bachelor program, you may have to complete compulsory courses and elective courses (normally two units each) and can often choose areas of specialisation (e.g. majors). To be awarded a bachelor degree you need to complete the specified total number of units with a certain number studied in specific areas.

A single major is a field of disciplinary focus that has a value of at least 12 units (#12). It may be a compulsory requirement of the program.

A dual major (as distinct from a dual program) is a field incorporating advanced studies in two complementary areas with a value greater than or equal to either #20 or #24 units (depending on program), exclusive of introductory level courses.

An extended major is a field incorporating advanced studies with a single disciplinary focus with a value greater than or equal to either #20 or #24 units

(depending on the program), exclusive of introductory level courses.

A minor is a field with a discipline focus equal to approximately half the value of a major (i.e. #6 to #10 units).

Honours

If you are undertaking a bachelor degree, you will need to complete additional study to be considered for the award of honours.

All honours programs at UQ satisfy research training requirements to prepare you to progress to a Master of Philosophy and Doctor of Philosophy. An honours degree also provides the skills and knowledge in a specific context that are required to undertake professional work.

There are three models for honours programs at The University of Queensland:

- Model 1:

Enter a one-year Bachelor Honours degree, following completion of a three-year Bachelor degree in the same discipline.

- Model 2:

Enter a Bachelor degree and (at some point during that degree), if you meet the entry requirements, apply to change programs to a four-year (or more) Bachelor Honours degree.



- Model 3:

Enter a four-year (or more) level 8 Bachelor Honours degree: all students will graduate with honours.

You will be awarded a class of honours based on your academic performance in identified courses during the program. Class I, Class IIA, Class IIB, Class IIIA, or Class IIIB honours may be awarded, based on your grade point average (GPA) calculated using all or a subset of courses from your honours program.

Dual programs

A dual program enables you to study for two bachelor degrees at the same time, but in a shorter period than if you were undertaking them separately.

This means that you can study several areas of interest at once, gaining extra knowledge and skills to give you a competitive edge in the workforce.

To apply for UQ dual programs, you need to satisfy subject prerequisites and entry score requirements for both programs.

Upgrading

If you are not offered a place in your preferred program and want to improve your entry score or meet subject prerequisites, you can accept an offer in a program with lower entry requirements or with fewer prerequisites and try to improve your entry score during your first year of study. This is called upgrading.

Depending on your academic performance, your new entry score could be higher than your previous score, and you may meet the entry requirements for your preferred program. You will be required to follow the program rules and requirements of the program you are offered, but should seek guidance from faculty staff to assist with course selection for upgrading.

POSTGRADUATE **COURSEWORK STUDY**

Postgraduate coursework programs are the second level of tertiary study and, depending on the program you choose, may be available at Graduate Certificate, Graduate Diploma, Masters, or Professional Doctorate level.

Postgraduate program structure

The amount of time required to complete a postgraduate program generally ranges from six months to four years; and entry requirements vary according to the program.

Professional Doctorate programs are available in a very limited number of disciplines and entry requirements vary, although a Masters degree is usually a prerequisite.

Masters degree (Coursework) and Masters degree (Extended)

These qualifications generally require either a bachelor degree, graduate certificate or graduate diploma to gain admission, depending on the discipline of the entry qualification, and then one to two years

of study. Programs comprise specialist courses and a research component of at least four units.

Professional Doctorate

Professional doctorates are coursework programs that allow experienced professionals to improve their professional practice through the application of research to current problems and issues. Both coursework and research components are included. The doctoral research should make a significant contribution to the knowledge and practice of the profession.

Pathwavs

You may choose to do - if available - a Graduate Certificate only and then study progressively to the higher level programs of Graduate Diploma and Coursework

Masters; or, if you are eligible, you can enrol in a higher level program from the start.

Graduate Certificate

This level generally requires a bachelor degree to gain admission, and then one semester of study.

Graduate Diploma

This generally requires either a bachelor degree or a graduate certificate to gain admission, and then one year of study.

External mode

Some programs are offered in external mode (where course materials are provided online or via mail) so that you can study in your own country. If you choose an external program, you will not be eligible for an Australian student visa.

Transferring to RHD

If you wish to complete a research doctorate and have not completed undergraduate honours, you will need to undertake a research project or thesis to ensure you have the necessary research skills.

TERMINOLOGY

You will hear a lot of new terms at university - here is an explanation of some of them...

Australian student (also known as Domestic)

A student who is an Australian citizen or permanent resident, or a New Zealand citizen.

Bachelor degree

A qualification awarded for the first level of tertiary study, typically requiring three to five years of study. Blue Card

An identification card issued under the Commission for Children and Young People and Child Guardian Act 2000 that you need in order to work with children in Queensland, whether as paid employee or volunteer: you can apply for one through the UQ School administering your program. Blue card applicants undergo a complete national criminal history check.

Census date

The last date to cancel enrolment in a course without incurring financial liability. Census dates are 31 March for Semester 1, and 31 August for Semester 2 Summer Semester census dates change each year depending upon the start date of Summer Semester. Intensive teaching periods also have individual census dates that change each year according to the start date of the teaching period.

Compulsory courses

Courses that must be studied to complete the requirements of a program.

Confirmation of Enrolment (CoE)

A CoE is sent to you for when you wish to apply for a student visa, and is presented at your nearest Australian embassy, High Commission or Diplomatic Mission.

Course

A component of study within a program.

Coursework program

A postgraduate program where the assessable content by research represents less than two-thirds of the total assessable content (as distinct from a research higher degree).

Credit

- 1. Students receive credit towards a degree when they pass a course that is part of the program requirements.
- 2. Students changing programs (within UQ or from another university) may apply for credit, a value assigned for study completed in one program, towards the new program. See Credit transfer.

Credit transfer (or transfer credit)

Credit transfer may be granted when students change from one program to another, if the rules of the new program allow: check with the administrating Faculty.

CRICOS code

The Commonwealth Register of Institutions and Courses for Overseas Students (CRICOS) code indicates a registered program offered to international students studying in Australia on a student visa

Doctor of Philosophy (PhD)

A research higher degree program usually undertaken over three to four years which includes a research thesis comprising at least two-thirds of the work for the degree: honours class IIA bachelor degree minimum entry required.

Dual program

Two UQ degree programs undertaken at the same time (sometimes known as dual/parallel/combined/ double degrees).

Duration

The amount of time normally taken to complete a program, expressed in terms of full-time (F/T) or parttime (P/T).

Elective

A course that you may choose from a set of options. Some UQ programs allow elective courses to be taken from outside the main focus of the program or from other UQ programs.

Entry score

All undergraduate students are assigned a university entry score based on high-school or post-secondary study results. Once you complete the equivalent of one full-time year of tertiary study (bachelor level or higher), your ranking is converted to a score based on Grade Point Average.

External student

External students study by distance education and do not have to attend any on-campus classes, although attendance at residential schools may be required in some cases. Material is dispatched by mail or via the Web. International students can only study external programs from offshore.

Facultv

The major organisational unit within UQ, with responsibility for academic programs. Faculties may have a number of sub-faculty academic units called schools.

F/T

Full-time: 75 per cent or more (six units) of the standard full-time study load (eight units) per semester for most programs. As an international student in Australia, you must be enrolled in eight units per semester

Grade Point Average (GPA)

A statistic based on grades received and the number of units completed, indicating how successful you are in your studies.

Graduate entry

Indicates options available for some programs, only open to students who have already completed an undergraduate degree, or who have a particular GPA.

Honours

At UQ Honours may be awarded as a one-year bachelor honours degree following completion of a bachelor degree; or as a four-year bachelor honours degree. Some undergraduate programs allow eligible students to transfer to a bachelor honours degree at a defined point in the bachelor degree. IELTS

International English Language Testing System. Internal student

A student who attends classes (lectures, tutorials and practicals) on-campus during semester.

International student

A student who is not an Australian citizen or permanent resident, nor a New Zealand citizen. and is enrolled or proposes to enrol at an institution in Australia. Temporary residents of Australia are classified as international students

Major

An area of specialised study within a program of at least 12 units, e.g., history in Arts program, which may be a formal requirement. Extended and dual majors are when the specialised area comprises a higher proportion of the degree.

Master of Philosophy (MPhil)

A research higher degree program undertaken over a period of one to two years. The program includes a research thesis comprising at least two-thirds of the work for the degree: bachelor degree minimum entry required.

Masters by Coursework

Postgraduate program typically requiring one to two years (or two to four semesters) full-time study. Programs consist of a series of specialist courses and sometimes a research component.

Minor

A field within a program approximately half the value of a major.

Placement

Also called work placement, internship, industry study, clinical practice, practicum, fieldwork, clinical placement, practical work, teaching practice or industry experience - this is a period of practical, work-related experience designed to enable you to practise professional skills in a real-life setting.

Plan/Field

A plan is an area of study within a program, for example, biology, physics, mathematics, or history. Prerequisite

Courses that you must have previously passed in order to enrol in a particular course or program.

Professional Doctorate

A coursework program designed for experienced professionals who wish to improve their professional practice by applying research to current problems and issues in their field.

Program

A sequence of study leading to the award of a qualification such as a bachelor degree, graduate diploma, or PhD.

Program code

A unique identifying number the University assigns to a program.

P/T

Part-time.

Quota

Some programs have limited places available.

Research Higher Degree (RHD)

A postgraduate program where the assessable content by research represents more than twothirds of the total assessable content (as distinct from a coursework degree).

School

The core, sub-faculty academic unit, responsible for teaching, research and interaction with professional organisations. Course coordinators and lecturers generally work in Schools.

Semester

The University teaching year is divided into three semesters: Semester 1, Semester 2, and Summer Semester. Most programs only require you to be enrolled in Semesters 1 and 2 each year.

Units

Units (#) represent the value of individual courses that contribute to the total unit requirement of an academic program. A standard study load is eight units per semester.

Workloads

International students must complete their studies within the minimum duration of the program (student visa duration).

TEACHING AND GRADING

Teaching and learning styles

At UQ we use a range of teaching methods, including lectures, tutorials, laboratory practicals, fieldwork, group discussions, and online modules and workshops.

We want you to actively participate in class discussions and to ask questions. Please express your personal viewpoints – many lecturers will deliberately provoke arguments to encourage thinking and debate!

Apart from face-to-face contact, you will also complete assignments and examinations. And you are expected to spend as much time – if not more – on library research and independent study as you do attending lectures and tutorials.

To help you adapt to what is required, our Student Services team offers training throughout the semester for enhancing your learning, assignment writing, research, examination, presentation, and time-management skills.

Teaching spaces

Assessment

Assessment methods vary according to the course.

For example, you may have to write assignments, undertake mid-semester and/or end-of-semester examinations, present oral reports, join in debates, participate in individual and group projects, or prepare research summaries and laboratory practical reports.

Individual course assessment requirements are set out in course profiles (outlines), available online at the start of classes, and are usually explained to you in the first lecture.

Your academic results will be determined by the relevant faculty at the end of each semester.

UQ strongly emphasises written expression in most forms of assessment, but good speaking skills are also essential: you will develop both during your program.

International student definition

You are an international student if you are:

- a Temporary Resident (visa status) of Australia
- a Permanent Resident (visa status) of New Zealand, or

- a resident or citizen of any other country.

- You are **not** an international student if you are:
- an Australian citizen (living in Australia or as a resident overseas)
- an Australian Permanent Resident (visa status), or
- a New Zealand citizen.

Permanent residency

If you become a permanent resident before starting your first semester of study, and you have been offered a place as an international student, you will not be able to retain that place. Instead, if you are appying for an

undergraduate program, you must apply for a Commonwealth Supported Place (CSP) through the Queensland Tertiary Admissions Centre (QTAC).

If you are applying for a **postgraduate** program, you should contact the relevant faculty.

If you obtain permanent residency after you have enrolled at UQ, other procedures apply. Please contact the Student Centre at that time for more information.

Documentation required

When you apply to UQ, please ensure that you submit certified copies (see Notes below) of up-to-date transcripts and award certificates with your application.

Comprehensive grading scales will also be needed for any tertiary studies you have undertaken. Certified official translations are required for all documents in languages other than English.

If you are waiting for transcripts or current results, you may still submit an application. Submit the evidence of English Language Proficiency (unless you intend to sit a test), and post-secondary results you have so far with the application form.

Please forward any outstanding documents as soon as you receive them to UQ's International Admissions Section. Please ensure that these documents are clearly marked with your UQ Student ID (if available), family name, first name, date of birth, proposed program and a note that an application has already been submitted.

NOTES: A certified copy of an original

document is one that has been certified as a true copy of the original by one of the following: an authorised agent of the University (see www.uq.edu.au/international/edureps), a university or college registrar, a school principal, a Justice of the Peace, a Notary Public (i.e. practising solicitor), or an examining authority. Authorised agents of the University must include ALL of the following: agency company stamp, signature of the agency staff who sighted the original document/s, and a certification statement saying that the original has been sighted.

Visas

All international students applying to study in Australia must have a student visa unless they have an alternative visa that enables them to study full-time.

To be eligible to apply for an Australian student visa, you must undertake a program on campus at UQ on a full-time basis.

The majority of visas are processed under SVP. Visas for programs ineligible for SVP can take longer. It is your responsibility to ensure that you receive your visa in enough time to commence studies at the University.

Some UQ programs are offered for mid-year entry which means you can commence in Semester 2 (July).

Programs and courses

Suspensions, deferrals and cancellations

If you wish to defer (i.e. delay commencing), please contact the International Admissions office as soon as possible: you may be able to apply for a deferral for up to two years, depending on the program and its availability.

Once you commence study, you may also suspend or cancel your enrolment on compassionate or other compelling grounds. The University may also suspend or cancel your enrolment for a number of reasons including misbehaviour, poor academic standing and unsatisfactory academic progress.

Please note that any suspensions, deferrals or cancellations may affect your visa.

Enrolment and Progression rules

Students under 18 years of age

If you are an international student wishing to study on a student visa and you will be under 18 years of age at the time you commence your studies, you will require a guardian to be with you in Australia. The University of Queensland cannot act as a guardian, and will not be able to organise care and welfare arrangements for you.

RESEARCH HIGHER DEGREE PROGRAMS

Your PhD: your career

UQ has supported more than 15,000 students in their academic pursuit of a research higher degree. Now is the time for you to achieve your research goals at one of Australia's leading research universities.

Doctor of Philosophy (PhD)

A PhD is one of the highest degrees that can be awarded. It is an advanced qualification required for most academic and research positions.

PhDs foster the development of independent research skills, including the capacity to formulate a significant problem, to develop mastery of conceptual and methodological skills, and to relate the research topic to a broader framework of knowledge in a relevant disciplinary area.

Master of Philosophy (MPhil)

An MPhil is an internationally recognised postgraduate research degree that involves undertaking a significant research project.

The MPhil program provides you with an opportunity to develop and enhance your analytical and research skills through independent investigation in a specific field. This involves producing a thesis that demonstrates your capacity for critical analysis and application of specialist knowledge.

Why do a research higher degree (RHD)?

Most PhD and MPhil candidates undertake a research degree because they are driven by the desire to advance their career opportunities or satisfy their intellectual curiosity. Graduates from RHD programs typically enjoy academic or research careers within tertiary institutions or a broad range of professional and leadership roles within industry and government.

As well as vocational benefits, completing a research higher degree positions you as an expert, and provides opportunities to travel, network and explore.

Research Quarters

International RHD candidates at UQ enjoy a significant advantage over students at most other tertiary institutions with annual tuition fees divided into quarters instead of semesters. This reduces the pressure to submit research prematurely due to financial pressures.



English language pathways to UQ

If you meet all the academic entry

requirements for your UQ program (see separate program supplements), but need further English language training, then you are eligible to undertake an English language pathway.

English language pathway students receive a Package Offer to UQ which includes an offer for a place in an ICTE-UQ English course plus an offer for a place in a UQ program (conditional on meeting the English language proficiency requirements for entry).



The General English/English for Academic Purposes (GE/EAP) Pathway

The Bridging English Program (BEP) Pathway

IELTS (or other UQ-accepted test) + UQ Application

To apply for an English language pathway, submit a complete UQ program application to International Admissions. You must include UQ-accepted English language test results with your application. These will be used to calculate how many weeks you will need to study English at ICTE-UQ and which of the following two English course options is right for you.

GE/EAP (variable length)

The GE/EAP pathway includes a variable number of weeks depending on your English language ability. You will be tested on your first day at ICTE-UQ and placed in either a GE or EAP course and class level. The table below provides an estimate of how long you will need to study English at ICTE-UQ to reach the IELTS score needed to enter your UQ program.

IELTS (or other UQ accepted) Test

At the end of your GE/EAP course you must sit a UQ-accepted test to demonstrate that you meet the English language proficiency requirements for your UQ degree program. ICTE-UQ administers two-three IELTS test dates each month.

If you require further English language training you may be able to extend your enrolment at ICTE-UQ.

Concurrent Diploma

At UQ, you can undertake an undergraduate diploma concurrently with your bachelor degree. You generally spread the load as extra courses across the duration of your degree, but can sometimes study several of the required courses simultaneously in one or two semesters.

Study Abroad and Incoming Exchange

If you are an international student currently enrolled at an accredited overseas university, you may be eligible to study at UQ for one or two semesters under the Study Abroad and Incoming Exchange program.

If your university has an exchange agreement with UQ, you may be nominated for the Incoming Exchange program to UQ, where you submit your application and pay tuition fees to your home university (based on your home university's fee requirements). Credit for UQ courses successfully completed is normally transferable towards your home university degree.

If your university does not have an exchange agreement with UQ, or there are limited exchange places, you can apply as a Study Abroad student. In 2016, Study Abroad tuition fees are AU\$11,250 per semester. Credit gained at UQ is usually transferred towards your degree at your home university.



When you study at university, you will pay tuition fees and living costs



Statutory expenses

When you apply for a student visa and your program is not eligible for Streamlined Visa Processing (SVP), the Department of Immigration and Border Protection (DIBP) may ask you to prove that you have enough money to complete your studies.

If you are eligible for SVP, you must read and sign a financial declaration and return it to The University of Queensland along with your Acceptance.

General expenses

Fortunately, Brisbane rates well on cost of living indexes for Australian cities.

How much it will cost you to live in Brisbane will depend partly on your lifestyle preferences. As a guide, if you are living in shared accommodation off-campus you will pay approximately AU\$24,050 per calendar year. You will also need to consider establishment costs (approximately AU\$2990 if you live off-campus) when setting up your accommodation, and other ongoing living expenses such as public transport, entertainment, telephone costs, textbooks, photocopying, and clothing.

You will need personal access to a computer and the Internet at UQ. Although computers are available on campus, you might want to bring a computer with you, or purchase/hire one in Australia. Wireless laptop connections are available on all campuses and UQ provides basic access to the Internet for study purposes. If your Internet use is high you can purchase "top up" access at a reasonable cost.

If you buy a car, costs can vary from AU\$5000 to AU\$25,000 or more, and running costs after purchase price are about AU\$100 per week: we strongly recommend that you use public transport.

You also need to make allowances for recreation, emergencies, and health expenses not covered by OSHC.

Remember that exchange rate variations may also affect your budget.

TUITION FEES AND SCHOLARSHIPS

As an international student, you will have to pay tuition fees to UQ. You may, however, be eligible for a range of scholarships or financial aid from your home government.

Coursework award tuition fee

The University of Queensland has program-based fees for coursework award programs.

Program fees mean that all courses within a program are charged at the same tuition fee rate per unit for a given academic year. This means you will know what your tuition charges for that year will be.

The indicative fees assume that students enrol in a full-time study load (usually eight units per semester). For students who are not enrolled in a standard full-time study load, the fee is prorated. 2016 indicative annual/semester fees for programs, based on a standard full-time study load, are included in the 2016 Undergraduate and Postgraduate Program Supplements.

Each program's fees are indexed annually. The indexation rate is fixed approximately 18 months in advance of a particular academic year, thereby allowing you to plan your finances ahead of time. The University's intent is that fee rate increases will be kept to a minimum and that indexation rates will remain stable wherever possible. Since 2007 the average indexation rate has been four per cent.

To estimate the total cost of a program, multiply the semester or annual fee by the number of semesters or years. As a guide, you can add on the historical average indexation rate of four per cent per year (please note: this rate is subject to change).

Tuition fees received before program begins

Payment of tuition fee amounts greater than 50 per cent of the total indicative tuition fees for a student's program (or greater than 100 per cent for programs of less than 24 weeks duration) before the agreed starting day of the first study period of enrolment at UQ cannot be accepted and will be returned to the payer (see *Application for and payment of refunds*).

Application for and payment of refunds

Requests for tuition fee refunds must be made in writing to the Academic Registrar and submitted to the Student Centre. For refunds of tuition fees paid before a program begins, students may be requested to submit a refund request form with their bank account details.

Refunds to students in receipt of financial aid

Under US Federal William D Ford Direct Loan Program guidelines, the University is required to return the unearned portion of funds provided for study purposes to the US Government if the student granted the loan withdraws prior to completing 60 per cent of a study period (the US Financial Aid census date). No tuition fees are refunded to the US Government if the student withdraws having completed more than 60 per cent of the study period.

Student rights

Any agreement and the availability of complaints and appeals processes does not remove a student's right to take further action under Australia's consumer protection laws or prohibit the student's right to pursue other legal remedies.

UQ research higher degree scholarships

UQ provides more than AU\$39 million in scholarship funding support each year for the living and tuition expenses of research higher degree (RHD) candidates.

If you are a current or prospective RHD student, you may be eligible for financial support for tuition fees and living allowances. Scholarships are awarded through meritbased criteria to recognise excellence and reward outstanding candidates.

UQ Graduate School scholarship schemes for students are allocated in three competitively based rounds each year – in March, July and November – and include:

International Postgraduate Research Scholarships (IPRS)

Funded by the Australian Government, IPRS are awarded to outstanding international RHD students to cover tuition fees and Overseas Student Health Cover costs for commencing students, and are based on academic merit, research experience and/or potential, and alignment with UQ's research strengths.

UQ International Scholarships (UQI)

UQI scholarships support RHD candidates who are strongly endorsed by their school or institute, but have not secured an IPRS and UQ Centennial. UQI scholarships provide tuition fees and a living allowance to international RHD students to the equivalent value of the Australian Postgraduate Award.

UQ Centennial Scholarships (UQCent)

The UQ Centennial Scholarships are premier UQ scholarships awarded to outstanding candidates. The scholarship provides a living allowance for commencing students who have been awarded an IPRS, to the equivalent value of the Australian Postgraduate Award.

Top Up Assistance Program (TUAP)

The Top Up Assistance Program supports RHD candidates receiving a foreign Government scholarship or sponsorship with a living stipend below the Postgraduate Award, and who are strongly endorsed by their school or institute. The scholarship will provide a top up to the value of the Australian Postgraduate Award

Australia Awards Scholarships

Australia Awards Scholarships are long-term development awards administered by the Department of Foreign Affairs and Trade that aim to contribute to the long-term development needs of Australia's partner countries in line with bilateral and regional agreements.

They provide opportunities for people from developing countries to undertake full-time postgraduate study at participating Australian universities in order to develop skills and knowledge for driving change and contributing to the priority development outcomes of their own country.

The Awards include payment of an establishment allowance, all tuition fees, return airfares, living allowance and overseas health care cover.

UQ is a participating institution and has hosted Australian Government-sponsored students for more than 50 years.

Endeavour Postgraduate Scholarship

The Endeavour Scholarships and Fellowships offer support to non-Australians from participating countries to undertake postgraduate master by coursework or research in Australia. Recipients receive travel and establishment funding as well as tuition fee support.

The Endeavour Postgraduate Scholarship aims to:

- strengthen bilateral ties between Australia and participating countries
- showcase Australia's education sector
- build international linkages and networks.

Australian Centre for International Agricultural Research (ACIAR) Fellowships

The program directs activities to developing countries in five regions: Papua New Guinea and Pacific Island countries; East Asia; Mekong countries and China; South and West Asia; Sub-Saharan Africa; and Middle East and North Africa. LIVING COSTS

Expenses guide

The chart below does not include establishment costs. If you plan to live in off-campus rental accommodation you will also need to factor in money for approximately eight nights of temporary accommodation when you first arrive; buying furniture; setting up electricity, gas, home phone or a mobile phone account; rental bond (usually the equivalent of a month's rent: rental bond is refundable when you leave your rental property, provided the property is in a good condition); and two weeks' rent in advance.

In 2016, estimated establishment costs for one student living off-campus are AU\$2990, and for a family living off-campus (two adults and one child) they are AU\$7805.

Overseas student health cover (OSHC)

Overseas Student Health Cover (OSHC) is insurance that covers basic medical and hospital care that you may need when you are in Australia.

You must have OSHC if you have, or want to apply for, a student visa and you can obtain it from any government-approved OSHC provider.

OSHC only covers you from the time you arrive in Australia and so you may also need travel insurance while in transit. You will learn more about the Australian health system and health insurance during Orientation.

UQ's preferred OSHC provider is Allianz Global Assistance and the University can accept payment on their behalf.

Your Letter of Offer will indicate the Allianz Global Assistance OSHC fee for visa-length cover of OSHC, and the program deposit amount that is part of your tuition fee. When you have paid the deposit and OSHC, and signed and returned the Acceptance form, your Confirmation of Enrolment (CoE) will be issued. This will show that the OSHC has been paid, which will satisfy the student visa application requirements.

You will need to provide evidence of this cover before your CoE can be issued.

Childcare costs in Australia are very high (up to approximately \$95 per child per day). There are also long wait periods for places, so we recommend you place your name on several waiting lists well in advance. You will need to contact childcare centres directly before you arrive.

School tuition fees for children

The Department of Immigration and Border Protection requires that dependant children between the ages of five and 18 attend school full-time as a condition of the dependant visa. International fee-paying students must pay school tuition fees for school-aged children.

In Queensland, all state schools offer an optional Prep Year before primary school.

If you have school-aged children, you should email Student Services for assistance with applying for schooling and obtaining a Confirmation of Enrolment (CoE) which provides proof of school enrolment for your child's dependant visa application. Once you arrive in Queensland you can then register your children to attend a specific school near where you will be living. You should budget \$1400 per child per year for additional school expenses.

If you have received a scholarship directly from the Australian government and/or you are a PhD student, you may be exempt from paying school tuition fees for your schoolaged children who attend government schools in Queensland. Check Education Queensland's policy on the waiver of school tuition fees.

Working while studying

If you are residing in Australia on a student visa and want to work, the number of hours per fortnight (two weeks) you can work will depend on the type of student visa you have.

Holders of a Subclass 573 (Higher Education sector) student visa can work up to 40 hours per fortnight while their university program is in session, and unlimited hours during scheduled university breaks.

If you hold a Subclass 574 (Postgraduate Research sector) student visa, you can work unlimited hours a fortnight once you have commenced your masters by research or doctorate course of study in Australia.

This information applies to visas issued after 26 April 2008.

If, for any reason, your student visa is issued without the right to work, you will need to apply for a permission-to-work student visa after commencing classes. Please note that you will be required to obtain a Tax File Number (TFN) before undertaking work. You will hear more about these requirements during Orientation Week. Information about dependant family member working rights will be covered in the Families of International Students session offered by Student Services.

In general, you should not expect to cover tuition fees or living expenses from casual work. Part-time work can be difficult to find and there is much competition for these jobs. Most available jobs are nonprofessional and involve tasks such as waiting on tables, cleaning or sales.

If you are studying at UQ on a scholarship, you should contact your scholarship provider about how many hours you are permitted to work each week.

TOP TIP

Our top tips for househunting:

- Never sign up or pay any money for a private rental property without inspecting it first
- Attend an Accommodation information session
- Take some time to consider a few different suburbs – prices, size and quality may vary with location
- Try to meet all of the housemates before moving into a share-house if possible
- Make sure you can easily access public transport from where you choose to live
- Ensure you understand all of the tenancy documentation before you sign anything
- Before you sign anything, speak to one of our Accommodation Team members so they can check the documentation for you.

General off-campus rental housing

Share houses and apartments are the most common form of student housing, allowing you to save money and make friends.

Houses are generally shared by three or more students. Apartments, also called units or flats, are usually smaller and are shared by two or more people, depending on apartment size and personal preferences.

Weekly rent ranges from about \$150 to \$300 per person, depending on location, size, quality, and number of people. See suburb guide and interactive map on the UQ Accommodation website to find places to live.

The UQ Rentals website lists vacant rental accommodation for UQ students; however, we strongly advise that you arrange rental housing only once you have arrived in Brisbane so that you can inspect the property. To allow enough time to inspect a variety of long-term rental properties that best suit your needs, make sure to pre-book short-term accommodation. Please note:

- houses and apartments are usually rented (leased) for six- or 12-month periods and you will be charged fees if you break the lease early
- you will usually have to pay a bond equivalent to four weeks' rent, and rent is payable two weeks in advance
- security deposits for gas, electricity and phone connections may be required and are a separate cost
- houses are often rented unfurnished
- furnished or part-furnished houses and apartments are available, but rent is usually higher
- you will need to provide some sort of identification to sign a lease and the landlord or real estate agent may require proof that you study at UQ
- you also need to budget for food, public transport fares, household items, and ongoing utility costs such as gas, electricity, water, internet and telephone.

UQ St Lucia

You can choose from on-campus residential colleges, off-campus student housing, or privately rented houses and units.

On-campus residential colleges

There are 10 on-campus residential colleges at UQ St Lucia. Colleges generally provide individual bedrooms (usually with shared bathrooms), meals, laundry facilities, and common social and recreation spaces. They may also offer academic tutorials, pastoral care and religious observance.

On-campus accommodation is in high demand. To avoid disappointment, you should apply directly to the college you wish to live in even before you receive your UQ offer: please contact the individual college for application information (see table overleaf).

You should always consider an alternative option in case college accommodation is not available.

Off-campus student housing

Many independent, commercial companies provide student accommodation with a variety of purpose-built and managed housing complexes that comply with all relevant state legislation. These commercial company offerings vary in size, price, rent inclusions, room size, furnishings provided, and locations – all of which you will need to consider when looking at this type of accommodation.

You need to apply directly to the provider. However, you will still want to inspect the accommodation first to ensure it meets your requirements and that the inclusions provided meet your needs: go to Accommodation Services website for a list of preferred and other providers.
