## Admission requirements

An Australian bachelor degree or approved international equivalent with an average grade of 70 or above. Students with an average grade of 65 or above may submit a personal statement for consideration.

## Course description

La Trobe Law School's Juris Doctor offers an innovative, high-quality legal education with a global perspective on the law. This internationally recognised degree fulfils the academic requirements of the Victorian Legal Admissions Board for admission to practise law in Australia.

You'll learn from leading researchers and experienced practitioners in a friendly and supportive environment. Teaching is conducted in small classes and assessment tasks emphasise practical skills and hands-on experience.

Our unique work-integrated learning partnership with the Law Institute of Victoria allows us to match your interests with a Victorian law firm and award academic credit for your work experience. This real-world experience allows you to build valuable networks during work placements.

## Delivery

Juris Doctor core subjects are taught in Semester 1 and 2, with some electives offered in the Summer and Winter Semesters. We offer flexible teaching hours with the option of afternoon or evening classes. You will study at La Trobe's City Campus with access to contemporary interactive learning facilities in the heart of Melbourne's legal precinct.

## Program structure

### Core subjects and electives

The Juris Doctor is comprised of 16 core subjects, as well as eight electives. Students must complete the compulsory core legal subjects in the sequence designated by the Law School.

Elective subjects are drawn from the Master of Laws (see page 5), and are taught by local experts and international faculty from select overseas law schools.

## Course description

The only program of its kind in Australia, the Global Business Law program allows law graduates to study commercial law in areas of global interest. Students are taught by distinguished jurists and practitioners from all around the world, including Asia, Europe and the USA.

At La Trobe we are committed to producing law graduates with an international perspective. The era of globalisation increasingly requires people with a legal background to understand business, including the links between major business functions and the legal framework.

The Global Business Law program offers access to the latest developments in international commercial law and practice. Our broad range of offerings enable you to build on your knowledge and skills in an existing area of interest or specialisation, or move into an international business environment for the first time.

## Delivery

Global Business Law subjects are usually taught intensively over a five-day period in the Summer and Winter Semesters. Some subjects may be offered during Semester 1 and 2. Classes take place at La Trobe's scenic Melbourne Campus in the suburb of Bundoora.



## Program structure

### Core subjects and electives

Students will usually complete 12 subjects comprising three or four core subjects (depending on background) and eight or nine electives. Both core subjects and electives are drawn from the Masters of Laws program (see page 5).

### Expected learning outcomes

- An increased capacity to think critically and analytically about research questions.
- Enhanced confidence to present legal concepts in a compelling way.
- Knowledge and skills to build on an existing specialisation, or move into the international business environment for the first time.
- Skills to examine and interpret commercial law in a global context.
- The ability to apply legal principles to international trade, commercial arbitration and business transactions.

## Admission requirements

An Australian bachelor degree or approved international equivalent.

## Course description

Taught by distinguished academics and practitioners from around the world, La Trobe's Master of Laws is an internationally relevant and contemporary qualification. This degree allows you to construct a course of study with a strong global and international focus, taught by distinguished academics and practitioners from Australia, Europe and the USA.

The degree will be of interest to those wishing to expand their knowledge and skills in order to be able to practise in a global legal market but not necessarily exclusively in a commercial environment.

## Delivery

Subjects are usually delivered in block mode over five days during the Summer and Winter Semesters. Some subjects may be offered during Semester 1 and 2. Classes take place at La Trobe's scenic Melbourne Campus in the suburb of Bundoora.

## Program structure

### Core subjects and electives

Students will usually complete 12 subjects comprising three or four core subjects (depending on background) and eight or nine electives. In any semester, a minor thesis of 12,000 words equivalent to two electives may be undertaken subject to approval.

Subjects will focus on areas of global interest, including international business and arbitration law, USA business and corporations law, intellectual property law and Asian and European business law; but may also include subjects in alternative dispute resolution, comparative legal traditions, international criminal law and public interest law.

Subjects offered may be capable of being credited to other Master of Laws programs in Australia, for further information please contact the course coordinator.

## Advanced standing

For information about advanced standing, contact the course coordinator. Advanced standing will be assessed on a case-by-case basis.

## English language requirements

### IELTS Academic

Minimum score of 6.5 with no individual band score less than 6.0.

### TOEFL\* Paper-based

Minimum score of 575 with a minimum score of 5 in the Test of Written English.

### TOEFL\* Internet-based

Minimum score of 80 with minimum overall for SLR 18; W 22.

### La Trobe Melbourne (ELICOS)

ELICOS Level 6B - 60% overall including 60% in the final exam.

### Pearson Test of English (Academic) (PTE)

Minimum score of 64 with no communicative skill score less than 59.

### Cambridge Certificate of Advanced English (CAE)

A grade of B or higher.

### Cambridge Certificate of Proficiency in English (CPE)

A grade of C or higher.

\* If you are having your TOEFL results sent directly to La Trobe University, please note that our TOEFL institution code is 9785.

## Practising overseas

Qualifying requirements to practise in overseas jurisdictions vary. If you want to practise overseas, you'll usually have to do further study in the country that you want to work in. To discuss requirements for individual jurisdictions, contact the course coordinator.

## Student visas

It is your responsibility to obtain a valid passport and student visa before you enter Australia for study purposes. Visa assessment levels are determined by country of citizenship and course type. # LIVING IN MELBOURNE

Melbourne is Australia's best city for international students and second best in the world ahead of Tokyo, Sydney and London. Melbourne received a perfect score (100/100) for student mix, which looks at the city's student population, levels of social inclusion, and tolerance.\*\* A diverse student population and a high level of social inclusion and employer activity add to Melbourne already having:

- a high quality of living
- a busy calendar of cultural events, from fashion and food to comedy and live music
- a range of high quality museums
- an excellent range of music venues, cafes, restaurants and bars, sporting events, and natural beauty.

## Entertainment and recreation

Melbourne is often referred to as Australia's cultural and sport capital. It has a thriving live music scene, art galleries, museums and a multitude of major festivals and events such as the Comedy Festival, the International Film Festival and the Fringe Festival, to name a few. There is also an abundance of multicultural food in Melbourne and you can experience some of the world's best cuisine, from fine-dining restaurants to food trucks.

## Weather

Victoria is located in the south-east corner of Australia and enjoys a temperate climate with four distinct seasons. The hottest months are January and February, and the coolest months are usually July and August. In summer, temperatures can reach over 40°C, while in winter, around Victoria, temperatures can range from around 2°C to 15°C.
