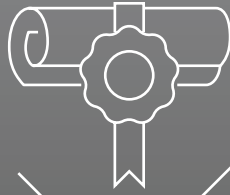

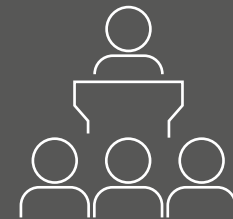

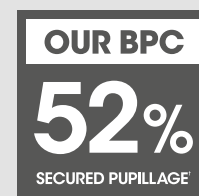

The Solicitors Qualifying Examination (SQE) is the new centralised assessment for anyone who wants to qualify as a solicitor in England and Wales. ### MASTER OF LAWS (LLM) LEGAL PRACTICE (SQE1&2)

This LLM incorporates SQE1 and SQE2 training to ensure you're fully prepared for both the SQE1 and SQE2 assessments, as well as your career as a solicitor. It also includes additional content considered highly desirable by law firms, such as key practice areas and additional modules on innovation in legal services, how to develop your professional effectiveness and understanding your clients' need.

### SQE1 PREPARATION COURSE
